Product description

The keyboard and mouse are designed with the advanced 2.4 GHz wireless technology, which ensures consistent and reliable connectivity. The keyboard is designed with the popular hotkey functionality, which enables one-touch control to quickly play, adjust, or mute audio and video files. The mouse features high-precision laser and scroll wheel side-to-side scrolling, which help you easily navigate through documents and Web pages. The mini nano dongle, which supports the plug and play functionality, is stored neatly inside the mouse for travel.





Figure 1. Keyboard front view




Figure 2. Keyboard rear view




Figure 3. Mouse front view




Figure 4. Mouse rear view

Chapter 2. Installing and uninstalling the device driver

This chapter provides instructions on how to install and uninstall the device driver of the keyboard and mouse.

Installing the device driver on Windows operating systems

To install the device driver on the Windows XP, Windows Vista, Windows 7, Windows 8, or Windows 8.1 operating system, do the following:

1. Save any open documents and exit all applications.
2. Insert the *Software and User Guide Disc* into the optical drive. The disc starts automatically. If the disc does not start automatically, do one of the following:
 - If the autoplay window opens, click **Run ViewHtml.exe**.
 - If the autoplay window does not open, do one of the following:
 - For the Windows XP, Windows Vista, or Windows 7 operating system, go into **My Computer** or **Computer**, then double-click the CD/DVD drive icon.
 - For the Windows 8 or Windows 8.1 operating system, open File Explorer and click **Computer** or **This PC**, then double-click the CD/DVD drive icon.
3. Select your language.
4. Click **Software** in the left pane of the window.
5. Follow the instructions on the screen to install the device driver.

Uninstalling the device driver from Windows operating systems

To uninstall the device driver from the Windows XP, Windows Vista, Windows 7, Windows 8, or Windows 8.1 operating system, do the following:

For the Windows XP operating system:

1. Click **Start → Control Panel** or **Start → Settings → Control Panel**.
2. Depending on your Control Panel mode, click or double-click **Add or Remove Programs**.
3. Select **Lenovo Ultralim Plus Wireless Keyboard & Mouse Driver**, and then click **Remove**.
4. Follow the instructions on the screen.

For the Windows Vista or Windows 7 operating system:

1. Click **Start → Control Panel** or **Start → Settings → Control Panel**.
2. Depending on your Control Panel mode, do one of the following:
 - Click the **Uninstall a program** option under the **Programs** menu.
 - Click **Programs and Features**.
3. Select **Lenovo Ultralim Plus Wireless Keyboard & Mouse Driver** and then right-click your mouse. The **Uninstall/Change** option is displayed.
4. Click **Uninstall/Change**.
5. Follow the instructions on the screen.

For the Windows 8 operating system:

1. Go to Control Panel by doing one of the following:

 - From the Start screen, do the following:
 - a. Move the pointer to the top-right or bottom-right corner of the screen to display the charms.

 - c. On the Apps screen, scroll to the right side, and click **Control Panel** in the **Windows System** section.
2. Depending on your Control Panel mode, do one of the following:
 - Click the **Uninstall a program** option under the **Programs** menu.
 - Click **Programs and Features**.
3. Select **Lenovo Ultrastim Plus Wireless Keyboard & Mouse Driver** and then right-click your mouse. The **Uninstall/Change** option is displayed.
4. Click **Uninstall/Change**.
5. Follow the instructions on the screen.

For the Windows 8.1 operating system:

1. Go to Control Panel by doing one of the following:
 - From the desktop, move the pointer to the top-right or bottom-right corner of the screen to display the charms, and then click **Settings → Control Panel**.
 - From the Start screen, do the following:
 - a. Click the arrow icon  in the bottom-left corner of the screen to go to the Apps screen.
 - b. Scroll to the right side, and click **Control Panel** in the **Windows System** section.
2. Depending on your Control Panel mode, do one of the following:
 - Click the **Uninstall a program** option under the **Programs** menu.
 - Click **Programs and Features**.
3. Select **Lenovo Ultrastim Plus Wireless Keyboard & Mouse Driver** and then right-click your mouse. The **Uninstall/Change** option is displayed.
4. Click **Uninstall**.
5. Follow the instructions on the screen to uninstall the device driver.

Chapter 3. Installing the keyboard and mouse

This topic provides information on how to install the keyboard and mouse.

Note: Before you install the keyboard and mouse, make sure that you have installed the driver correctly.

To install the keyboard and mouse, do the following:

1. Install the mouse by doing the following:
 - a. Press the battery compartment release button.




Figure 5. Opening the battery compartment

- b. Take out the dongle.




Figure 6. Taking out the dongle

- c. Connect the dongle to an available USB connector on the computer.




Figure 7. Connecting the dongle to a USB connector

- d. Insert two AA batteries into the mouse compartment according to the polarity indicators.




Figure 8. Installing the mouse batteries

- e. Close the battery compartment cover and slide it forward until it clicks into place.




Figure 9. Closing the battery compartment cover

- f. Push the power switch to the on position and the LED (light-emitting diode) is on.




Figure 10. Pushing the power switch on

Notes:

- The green LED indicates that the mouse is ready for use.
 - The flashing red LED indicates a low battery power level.
 - Push the power switch to the off position when you are not using the mouse. This extends the battery life.
2. Install the keyboard by opening the battery compartment cover and installing two AAA batteries according to the polarity indicators. The keyboard is ready for use.




Figure 11. Installing the keyboard batteries

When you do not use the keyboard and mouse, store the dongle in the battery compartment of the mouse or the keyboard as shown:




Figure 12. Storing the dongle in the mouse battery compartment




Figure 13. Storing the dongle in the keyboard battery compartment

Lenovo warrants that each Lenovo hardware product that you purchase is free from defects in materials and workmanship under normal use during the warranty period. The warranty period for the product starts on the original date of purchase as shown on your sales receipt or invoice or as may be otherwise specified by Lenovo. The warranty period and type of warranty service that apply to your product are as specified in "**Part 3 - Warranty Service Information**" below. This warranty only applies to products in the country or region of purchase.
